

## Preliminary Proposal to Restructure K-12 Levy Equalization

District Detail by Tier. Reduction Implementation in Calendar Year 2013

**Tier 4 Districts**---100% Reduction. The tax rate is 100% to 150% of the statewide average tax rate for a partial levy. Impacts 96 districts.
